Memorandum of Understanding Between Clinton County, the Town of Schuyler Falls, and the Town of Plattsburgh

WHEREAS, Clinton County is in the process of designing and constructing a new water main to extend water service to residents along the Sand Road in Morrisonville, Town of Schuyler Falls; and,

WHEREAS, this new water line will affect Town of Schuyler Falls residents and connect to the Town of Plattsburgh water system; and,

WHEREAS, a copy of said Memorandum of Understanding among Clinton County, Town of Schuyler Falls and the Town of Plattsburgh is attached hereto and made a part thereof; and

WHEREAS, said Memorandum of Understanding has been reviewed by Scott Stoddard, Director of Water and Wastewater, Ronald LaBerge, consulting engineer for the Town and

MEMORANDUM OF UNDERSTANDING

Between Clinton County the Town of Schuyler Falls and the Town of Plattsburgh

Whereas, Clinton County (the "County") the Town of Schuyler Falls and the Town of Plattsburgh (collectively the "Parties") are exploring the option of developing a public water system on Sand Road in the Town of Schuyler Falls in order to provide public water to approximately 60 parcels; and,

Whereas, the County has pursued applications for grant funding to assist with the cost of this public water system and,

Whereas, the County is currently engaged with the Department of Environmental Conservation, Division of Environmental Remediation in the investigation of emerging contaminants, including PFAS, which may be attributable to County owned property, among other potential responsible sources. As part of this process, the New York State Department of Health has installed Point of Entry Treatment Systems for multiple residences on Sand Road and,

Whereas, the County has indicated that all the potentially responsible sources have not been identified, and the engineering costs to study potentially responsible sources may exceed the cost of installation of a new public water system, and formation of a water district for the residents of Sand Road, without actually alleviating any contaminants and,

Whereas, the County has obtained grants as described below to assist with the cost of protecting public health by avoiding exposure to the emerging contaminants with the installation of a new public water system which is in the best interests of the County and the public and,

Whereas, the County has applied for and been awarded a Bipartisan Infrastructure Law Emerging Contaminants grant, funded through the Drinking Water State Revolving Fund, in the amount of \$5,000,000;

Therefore, the Parties will proceed based on the following understandings:

- 1. The County has applied for, and been awarded, a NYS Water Infrastructure Improvement Act (WIIA) Grant and Bipartisan Infrastructure Law Emerging Contaminants funding 2022 award;
- 2. The Town of Plattsburgh agrees to supply water to the proposed district through an existing interconnection with the Town of Schuyler Falls Morrisonville Water District up to 15,000 gallons per day. The proposed water district shall have a master meter installed to account for water provided to the district at a point prior to the first customer.
- 3. The County, with the consent of the Town of Schuyler Falls, will enter into an

- operation and maintenance agreement with the Town of Plattsburgh for the proposed district. Said agreement shall be transferable to the Town of Schuyler Falls following the two-year period of County operation and maintenance responsibility described below.
- 4. The Town of Schuyler Falls understands that the County will be accessing the water main at the Sand Road and NYS Route 22B intersection in order to provide an 8" ductile iron water pipe to provide public water on Sand Road, to include hydrants, valves, water services and all other necessary appurtenances.;
- 5. The County's engineers have prepared a preliminary engineering report for the project and the Town of Schuyler Falls generally concurs with the proposed design which generally includes
 - a. A hydro-pneumatic pumping system including a backup generator. The system will be capable of providing up to 1,000 gpm of fire flow through the use of high service pumps.
 - b. Interconnection near the Newell Court and Sand Road intersection to include an emergency isolation valve and any other appurtenances as may be required. The final interconnection design must be approved by the Town of Plattsburgh Water Department.
 - c. To the extent necessary, improvements to the Morrisonville Water District will include replacing some of the existing 8-inch asbestos cement pipe. It is agreed by the County the replacement pipe shall be 12-inch ductile iron extending from the Route 22B bridge over the Saranac River (starting on the west side of the bridge) up to the intersection of Sand Road and Route 22B. The improvements shall include, in addition to the pipe and related appurtenances, all necessary restoration of the work area disturbed by the construction. It shall not include replacement of pipe that was recently installed as part of the NYS DOT bridge replacement project, regardless of pipe size. The County Engineers will field identify the location of this recently installed pipe.
- 6. The County will reimburse the Town of Schuyler Falls and the Town of Plattsburgh for any fees and costs in assisting with this project, including, but not limited to legal, engineering, publications, referendum expenses and any other expenses attributable to water district formation through either Articles 12 or 12-A of the Town Law (if required). This will also apply to work relevant to the grant applications awarded and the work within the scope of the grant that requires actions by either Town;
- 7. The County will bear the entire capital cost of the project and there will be no debt attributable to the proposed water district formed as a result of the actions contemplated in this Memorandum of Understanding.
- 8. The County will pay all operation and maintenance costs for the district for the first two full years of operation. The two-year period shall commence on January 1st of the year following connection of all occupied properties in the proposed district.
- 9. The Parties understand that the Town of Schuyler Falls cannot guarantee the creation of a water district on Sand Road.
- 10. The County and its representatives will attend and present to the property owners the proposed project and costs that can be expected to be incurred by the property owners.

11. The project will include the connection of all existing properties within the district to the water system and the abandonment of the existing wells as agreed to by the property owners. All properties connected to the water system shall be individually metered

Resolution Supporting Empire State Development's (ESD) Designation of A Cellular-Specific Point Person to Lead the State's Efforts on Enhancing Cellular Coverage, and Further Encouraging the State to Implement a Unified Strategy to Assure Every Major Road Corridor has Reliable Cell Coverage as Recommended by ESD's Upstate Cellular Coverage Task Force Final Report

WHEREAS, cellular service is vital to public safety and the economic wellbeing of communities throughout the Adirondack Park; and

WHEREAS, county officials report that approximately 70 percent of 9-1-1 calls originate from cellular phones; and

WHEREAS, in a recent survey hosted on a State Senate website of almost 2,000 Adirondack Park residents, 99 percent of respondents reported owning a cellular phone and 67 percent reported that they rely exclusively on a cellular phone; and

WHEREAS, dependency on cellular service is significant and growing, which speaks to the absolute necessity of improved coverage and service; and

WHEREAS, the State of New York helped respond to this reality in the North Country by working aggressively to deploy COWS (Cells On Wheels) to provide adequate emergency response capacity to serve visitors to the World University Games; and

WHEREAS, state officials are proposing that Empire State Development (ESD) designate a point person to coordinate the state's efforts to enhance cellular coverage, similar to

the manner in which ESD designated a point person to coordinate the state's efforts to expand broadband coverage; and

WHEREAS, the Office of Renewable Energy Siting (ORES), which works to align all state agencies and state policy regarding renewable energy siting and implementation, serves as another successful example of the state coordinating its strategy on important infrastructure matters; and

WHEREAS, barriers to achieving the state's goals with respect to both broadband and cellular coverage enhancement continue to exist within some state agencies, including but not limited to NYSDOT right-of-way requirements, tax policy, and APA restrictions, and an approach similar to ORES would be beneficial in overcoming these barriers; and

WHEREAS, improving broadband and cellular coverage is a safety issue, a public imperative widely demanded by our constituents, and has become increasingly regarded as a basic necessity; and

WHEREAS, some state policies, especially the APA's "substantial invisibility" standard, are not keeping pace with these trends and instead becoming antiquated and counterproductive from the perspective of emergency services best-practices in place elsewhere in New York State, including co-location of multiple telecommunication systems on cell towers; and

WHEREAS, APA's longstanding claim that the telecommunications industry does not oppose the "substantial invisibility" standard is inaccurate, demonstrated most recently in comments entered by Nixon Peabody into review of the 2002 APA Tower Policy, which recommend "that the Agency modify its 2002 policy that requires telecommunications facilities over 40' tall be 'substantially invisible,'" and which characterize that requirement as an "arbitrary standard [that] is the main impediment to delivering much needed reliable wireless telecommunications service to a greater portion of the Park;" and

WHEREAS, the general public is increasingly supportive of common sense policy changes that promote a more appropriate balance between public safety and aesthetics while maintaining sensitivity to the environment, as reflected in the aforementioned public opinion survey, in which 90 percent of respondents supported changes to the APA's "substantial invisibility" standard; and

WHEREAS, the state has begun taking steps indicating that policymakers recognize these challenges, including the issuance of Empire State Development's Upstate Cellular Coverage Task Force Final Report and APA's advancement of a General Permit to assist with cellular coverage expansion; now, therefore, be it

RESOLVED, that the Town of Plattsburgh hereby supports the proposed designation by ESD of a point person to coordinate the state's efforts to enhance cellular coverage, and formally asks Governor Kathy Hochul to further enhance the state's efforts on broadband and cellular coverage expansion by employing a model similar to ORES that is respectful of the home rule

process and designed to streamline policymaking across state agencies in pursuit of moving the state more expeditiously toward its goals; and be it further

RESOLVED, that the Town of Plattsburgh hereby joins emergency service and telecommunication professionals, and other towns and villages across the Adirondacks, in urging the APA and the Governor to review the 2002 APA Tower Policy's antiquated "substantial invisibility" standard, which stands as the main impediment to delivering reliable telecommunication services necessary for public safety in large portions of the Adirondack Park; and be it further

RESOLVED, that copies of this resolution be forwarded to Governor Kathy Hochul, Adirondack Park Agency Executive Director Barbara Rice, State Senator Dan Stec, State Senator Mark Walczyk, Assemblyman Matt Simpson, Assemblyman Billy Jones, Assemblyman Ken Blankenbush, Assemblyman Robert Smullen, AATV, and Adirondack Inter-County.
