Dear Members of the Town Board,

It is with profound gratitude and genuine humility that I submit my resignation as Supervisor of the Town of Plattsburgh, effective Wednesday, November 12, 2025, at close of business.

I am deeply honored to have been elected to serve as the Assembly Member for the 115th District of the New York State Assembly. As I step into this new role, I do so mindful of the foundation we have built together and the strong future we have set in motion for our Town.

Serving as Town Supervisor for nearly a decade has been the greatest privilege of my life. Representing approximately 12,000 residents has been both a high calling and a tremendous responsibility. With stewardship of a budget of roughly \$20 million and oversight of 56 employees. I have been honored to work alongside this Board, our dedicated staff, local businesses, community origination and residents to strengthen our community's future.

Throughout my tenure, we have consistently presented and adopted budgets that remained under the New York State tax cap while continuing to deliver high-quality services to our residents.

Reflecting on our shared accomplishments fills me with immense pride:

- · Advanced the \$24 million Water & Wastewater Capital Plan, focused on health/safety, sustainability and economic development that demonstrates a clear commitment to the long-term health and growth of our Town and region.
- · Crafted and began implementing the Town Center Smart Growth Plan, positioning our community for sustainable development and an enhanced quality of life.

- Celebrated the Town of Plattsburgh as the "Home of the Michigan". From Michigan Month to the inaugural Michigan Fest launched with the partnership of UFirst Federal Credit Union and DCFU with the raising nearly \$20,000 for the Battlefield Memorial Gateway Project.
- Seized once-in-a-lifetime opportunity by harnessing the Total Solar Eclipse over Plattsburgh showcasing our community's spirit and hospitality.

Over these years, we have seen millions of dollars in private investment and grant funding invested in the Town, and hundreds of thousands of square feet of new development take shape, a testament to our shared vision, discipline, and perseverance.
